DECLARATION

1. I, the above signed, in consideration of and as a condition of acceptance of my entry in this Old Fashioned County Picnic, for myself, heirs, executors and administrators hereby waive any and all claim, right of cause of action which I or they might otherwise have for arising out of injury, damage or claim of any description whatsoever which I may suffer or sustain in the course of or consequent upon entry or participation in the said event. 2.
